Updates From the October Board Meeting

1.The General Village Election will be held on Wednesday, March 18, 2026 at Village Hall, 3 Pleasant Ave., Port Washington, NY 11050 between the hours of noon to 9:00 p.m. Two Trustee positions and the Village Justice are on the ballot.

2.The January 13, 2026 Board Meeting has been rescheduled to Tuesday, January 20, 2026 @ 7:30pm in Village Hall, Port Washington, NY 11050.

3.There will be a Public Hearing on Thursday, November 13, 2025 @ 7:30 p.m. at Village Hall to consider adoption of the following bills:

Bill No. 4 of 2025 – The Board of Trustees desires would amend Village Code Ch.170-10 in order to restrict use of Village Recreational Parking Lots to enable the intended users of such spaces to do so, and to prohibit use of such lots other than for the intended purpose, and, in so doing, to protect the health, safety and welfare of the Village and its residents. This Local Law could also impose hours of parking and a time limit to vehicles parked at Bay Walk Park.

Bill 5 of 2025-- A proposed local law amending Chapter 176, "Zoning"; of the Code of the Village of Port Washington North, to regulate as a temporary permitted use the conducting of all yard, garage, tag and other similar sales of personal property within all residential zoning districts of the Village by, among other things, requiring a no-fee permit issued by the Village and restricting the frequency thereof to not more than two per calendar year.

4.The Board postponed the Public Hearing to consider the approval of the application submitted by Ethnic Foods, Inc. / Bombay Kitchen, for extension of their Conditional Use Permit to continue to process and manufacture certain foods on the premises at 85 Channel Drive, Port Washington, NY 11050 to Thursday, November 13, 2025 at 7:30 p.m. at Village Hall. The Board did grant an extension of the permit for a period to expire on November 13th, 2025 to ensure the installation, inspection and testing of the CaptiveAire ventilation system is complete and found acceptable by the Building Department and Board of Trustees.

Sidewalk & Apron Repair Schedule Update

Please be advised that due to ensuring roadwork and sidewalk work would not interfere with Halloween festivities, our contractors have moved their start dates to November.

Sidewalk and apron repairs will be started on November 3rd throughout the Village.

The following roads will be resurfaced curb-to-curb:

Roadwork will start Nov 10th to avoid any conflicts with our initial leaf pickup starting Nov 5th.

Our road contractor John McGowan and Sons will be reaching out directly to all affected homes in advance of any work commencing in order to ensure proper notification and that cars are removed from the street during construction.

Once notified, please do not leave trash or garbage cans in the street on pickup day.

Port Washington North NICE Shuttle Disruptions

The Village of Port Washington North has been made aware that the NICE Shuttle service running through our village has recently undergone an operator change, resulting in major service disruptions for our residents. We understand how vital this shuttle is in providing reliable transportation to and from the train station, and we are committed to doing everything in our power to help restore dependable service as soon as possible.

We have contacted our Nassau County Legislator Delia DeRiggi-Whitton to share the service disruption feedback from our community. We are working closely with her office and NICE Bus to identify the cause of these issues and to ensure solutions are implemented quickly.

NICE management's response to Legislator DeRiggi-Whitton's inquiry is as follows: "Yes, we are aware of the issues regarding the new drivers. In the short term, Supervisors will be dispatched to the area to ensure we are on top of the issues—this tends to happen when we have assignment changes. That being said, we take this seriously and will work through solutions. Thank you for the input. I hope to touch base by early next week with updates."

We apologize for any inconvenience this has caused and sincerely appreciate the community's patience and feedback during this transition. We will provide updates as soon as additional information becomes available.
